11. Summary of the new findings of the thesis:
 - 1) The thesis continues to develop and perfect a step the basis of the theory of legal responsibility in environmental protection in Vietnam. On the basis of findings of previous scientific work on deposit insurance, The Author of the thesis further clarifies the legal responsibility in environmental protection in the meaning of "positive" and "negative". Within the thesis scope of work, the Author conducts research in the direction of "negative" meaning, based on which, defining generally the legal responsibility in environmental protection, forms of domain and subjects of effect of the laws related to legal responsibility in environmental protection
 - 2) The Author figures out the prerequisites when consolidating legislation in legal responsibility in environmental protection, on which criteria it should be based.
 - 3) The Author gives an overall and comprehensive evaluation of theory and current situation of legal responsibility in environmental protection in Vietnam as well as the status of violations to environmental protection laws and jurisdiction in this area.

4) The Author brings proposals for consolidating legislation in legal responsibility in environmental protection in Vietnam. The proposals are based on the assessment of the weaknesses and drawbacks of the current legal system in legal responsibility in environmental protection in Vietnam with refined and selective adoption of the advanced regulations in legal responsibility in environmental protection of other nations..

12. Practical applicability: for the legislative consolidation in legal responsibility in environmental protection in Vietnam ; for the research of Lecturers and Students at the training facility specializing in law and not block legislation economists.

13. Further research directions: Some of the content set out in the study of topics such as legal responsibility in "positive" meaning; legal position of the bodies implementing environmental protection; measures of environmental ethics education, environmental awareness improvement of organizations and individuals.
