enforcement of civil judgments and decisions of the foreign courts in Viet Nam in comparable

connection with the provisions of related international treaties and the laws of some countries in the

world.

- Analyze and evaluate practical results on the recognition and enforcement of civil judgments and

decisions of the foreign courts in Vietnam in recent years, pointing out the reasons for the limitations

from the achievement.

- Recommend directions and specific measures to contribute to improving Viet Nam laws on the

recognition and enforcement of civil judgments and decisions of the foreign courts in Viet Nam to meet

the development requirements of Vietnam's market economy and international integration process in a larger and deeper manner.

The research results of the thesis employ practical meaning for the process of finalizing the laws on recognition and enforcement of the civil judgments and decisions of foreign courts in Vietnam.
