11. Summary of the new findings of the thesis:

This is the first monograph in Vietnam Jurisprudence at the level of doctoral dissertation research in a comprehensive, systematic procedural time limits in criminal procedure law. The thesis has the following contributions:

Firstly, clarifying the concept, characteristics, theoretical basis of the determined procedural time limits in criminal proceedings, the grounds specified and classified time limits in in criminal proceedings; studying and processing the formation and development about provisions on procedural time limits in criminal procedure law from 1945 to the time before the promulgation of the Criminal Procedure Code, year 2003; analysing and assessing procedural time limits stipulated in the criminal procedure law of some countries representing the typical legal traditions in the world.

Secondly, analysing and evaluating about provisions on procedural time limits in Vietnam's current criminal procedure law; Assessing the state of the procedural time limits applying in criminal procedure law in force in Vietnam, pointing out the advantages and results achieved as well as the violation of procedure time limits in practical application and cause of the violation.

Thirdly, interpreting and clarifying the requirements of judicial reform for the completion of provisions on procedural time limits; proposing solutions of completion of provisions on procedural time limits in in criminal procedure law and solutions to improve the efficiency applied in Vietnam.

12. Practical applicability:

The study procedural time limits in criminal procedure law is part of the reasoning of the criminal justice system. The thesis contributes to clarify concept, characteristics, theoretical basis of the determined procedural time limits in criminal proceedings, the grounds specified and classified time limits in in criminal proceedings.

The results and recommendations of the thesis will serve as a basis for the completion of provisions of procedural time limits in Vietnam's criminal procedure law to overcome the shortcomings and limitations in current law; ensuring to make the law of reasonable procedural time limits that follow the general trend of some countries in the world, in accordance with the specific conditions of Vietnam; as the basis for proposed solutions improving the quality, effectiveness of the fight against crime; ensuring human rights and upholding the responsibility of the entity conducting the proceedings in the implementation of procedural time limits.

The evaluations, proposals and recommendations of the thesis will be value that is practical reference for criminal lawmakers in the research process of completion of the criminal procedure law, as well as for practical staff in understanding, applying and implementing provisions on procedural time limits. At the same time, the thesis will be a value that is reference in the studying, teaching and training in criminal procedure law at the training facility for Bachelor of Laws as well as at the vocational training institutions law .
