11. Summary of the new findings of the thesis

11.1 In theory:

- The thesis has studied theory of management education activities outside class time at universities systematically.

- The basic concepts of self-management and the characteristics of the educational activities outside class time in colleges have been presented in detail.

- The thesis has studied the rationale systems on management of educational activities outside class time in order to promote the role of student self-management and the comprehensive content of the process. Thereby determining the scientific arguments and the appropriate approaches for management of education activities outside class time in Vietnamese universities during the current period.

11.2 In practice:

The thesis surveys and assess status of management of education activities outside class time in some universities in Vietnam, including the current status of the content management process management educational activities outside class time: from awareness of the managerial staff, faculty; organization; plan; implementation; leading; validation and evaluation of the content of educational activities outside class time to coordinate with local bodies, social political organizations responsible for management of students; Policy, regulation, management mechanisms related to educational activities outside class time of students.

The survey results showed that the status of efforts to manage staff, faculty and students of universities in management education activities outside of class time. However, there are some limitations in the management of educational activities outside of class time at the University of subjective reasons and objective.

12. Application possibilities in practice:

A system of management solutions to improve the efficiency to manage education activities outside class time of students to enhance student autonomy, which are proposed in the thesis can be implemented uniformly in Vietnamese universities, to promote the study of the role of student autonomy in learning and practice, contribute to achieve comprehensive education of university students in Vietnam in the current period.

13. The next research orientations:

1. Build a model of management of educational activities outside class time in perspective of enhanced autonomy for the university students.

2. Develop and complete operational processes for management education activities outside of class time to enhance autonomy for students.
