11. Summary of the new findings of the thesis

This is the first dissertation in the law field in Vietnam researching with the synthetic and fundamental view on mechanism of dispute resolution in Vietnam's private international law.

* About theoretical aspect: The thesis analyses theoretical issues on mechanism of dispute resolution in Vietnam's private international law which including definition, structure and relation between the components as well as criterions in establishing this mechanism. It emphasizes particular contents of private international law field and system of legal solutions to improve this mechanism. The content has many new points than the other previous research. The author also proposes some issues belong to mechanism of dispute resolution in Vietnam's private international law that need to be completed in theoretical field and in legal provisions.

* About practical aspect: The thesis analyses the real situation of the mechanism of dispute resolution in Vietnam's private international law, gives out the good points and the bad points of current provisions in relationship with application practice. The thesis proposes some main point of views, orientations and groups of basic legal solutions for improving Vietnam's private international law and for enhancing capacity and conditions of the individual and legal entity groups which taking part into the dispute

resolution mechanism in this field. These legal solutions need to be carried out in a sensible itinerary in order to contribute to Vietnam's process of building the State based on law, judicial reform and international integration.

Practical applicability, if any: The result of this research may be referred to or applied in codification and improvement Vietnamese policy and law in the field of private international law as well as activities of studying and teaching in this scientific branch at Vietnam National University and the others.
