11. Summary of new results of the thesis:

Firstly, the author clearly has shown theory basis about labor safety in Viet Nam in which the

authour has given his view about labor safety, law for labor safety, characteristics, roles and

principles of law about labor safety.

Secondly, the author has shown advantage points that law about labor safety in Viet Nam particular obtained in the previous years specially he has shown limitations about labor safety in Viet Nam.

Besides positive points and negative ones of law about labor safety, the process of executing law about labor safety in Viet Nam, the author also has shown that certainly weak points for organizing and executing that consequences are popular violation of law and a number of accidents each year are not small.

Thirdly, the author has given some directions for completing law about labor safety in Viet Nam and proposed three resolutions to complete law about labor safety in Viet Nam in which the resolution on building specialized labor safety law is considered as the priority.
