11. Summary of the new findings of the thesis:
  - Based on the multidimensional approach to the context of journalism and journal activities before the era of renovation (1986), the Thesis clearly points out the appearance of Vietnamese journalism and journal activities of Vietnamese Communist Party in this time period. It also mentions the requirements to the leadership of Communist Party during the renovation progress, and then contributes to clarifying theoretical and practical basis of the necessity of the Communist Party's guidance to journal activities.
  - The Thesis shows the importance of the Communist Party's guidance to journal activities through opinions, policies, measures to direct the political opinions, guidance and organization the staff, building journal system and developing the concerned legal system. This is the base for reconstruct the historical process of the guidance to journal activities from 1986 to 2006.

- According to many different document sources, the Thesis contributes to systematizing the opinions and policies of Communist Party to journal activities in two stages, with specific political missions, with three fundamental contents expressing the comprehensive and direct leadership of Communist Party to journal activities from 1986 to 2006.

- Based on the historical fact of the guidance of Communist Party to journal activities, the Thesis objectively judges the obtained achievements and the drawbacks during the guidance progress, and then reasons the strengths and weaknesses to draw the lesson about this issue from 1986 to 2006.

- The Thesis provides the science-based arguments affirming that the leadership of Communist Part is the key factor to assure the mission completion of journalism with identified targets and the effectiveness of journalism to society and the inner development of journalism, particular in the context of globalization and relationship diversification.

#### 12. Practical applicability:

- The Thesis contributes to the richness and vividness of the historical context during the first two decades of renovation not only through the leadership in economy, politics, culture and national security but the leadership in multidimensional, challenging and important field like journalism.

- The objective judgments of the achievements, drawbacks and experiences drawn from the leadership process of Communist Party to journal activities contributed to the important historical base for the policy making and implementing of journalism in the near future.

- The Thesis is necessary documents for research and learning about the history of the Party's work in journalism Academy of Journalism and Communication in particular, for the agencies and units working in journalism in general

#### 13. Further research directions:
